



PROGRAMS

Purulia suffers from very poor human development indicators among the districts of West Bengal. Poverty and lack of awareness coupled with the absence of public health interventions have created apathy among the people and a reluctance to adopt any behavior change.

The total population of Purulia is 2,927,965. Almost 40% of the population is considered socially excluded. About 21% of them are scheduled castes and 24% are tribes. Purulia suffers from very poor conditions in terms of hygiene, poverty, and lack of safe drinking water, resulting in major health problems such as diarrhea, malaria, filaria, TB, anemia, and others. Poor child birth and nutrition standards lead to high IMR and MMR. Open defecation, lack of sanitary latrines, poor educational standards for girl children, and poor awareness of HIV/AIDS also compound Purulia's heath situation And with thaty view, the efforts made by Agragami are directed towards providing basic health care services to the poor & marginalised people covered by it. Improvement in Nutrition, safe motherhood and provision of basic health care services, immunization and health education are the areas of importance and emphasis.

WATER TESTING LABORATORY

Water quality has emerged as a major issue in West Bengal despite fair achievements in coverage of rural population by safe water supply. Although all the habitations in the State are having access to drinking water, excess of arsenic, fluoride and iron poses a major threat to community health and general well being of people. The issue of water quality testing and surveillance was highlighted at the national level in 2006, when the Government of India launched the NRDWQM&SP. The programme provided a framework for the implementation of a State Level Water Quality Testing and Monitoring System.

Though the national guidelines recommended that field test kits be used for testing water samples, yet it was decided that laboratory based water testing will be adopted in the State based on the sub-district level laboratory infrastructure already available in the State.

Over view Water Testing Summary Report for the Financial Year -2014-15

SANITATION CAMPAIGN

In our rural areas due to inadequate information and illiteracy, adoption of environment friendly sanitation is totally neglected by the villagers of Purulia district. PDAMSMS from its inception has been trying to create awareness amongst the villagers covered by it, in this regard. With the help of UNICEF and Govt. of W. Bengal including local Panchayats, a Sanitary Mart was established at Jargo, Jhalda-I under Rural Sanitation Program in the year 1999. Which is now implementing 'community led' and

'people centered' program, TSC with "demand driven approach" and increased emphasis on awareness creation and demand generation for sanitary facilities in houses, schools and for cleaner environment.

IEC activities for the National Rural Drinking Water & Sanitation Awareness Week from 16th to 22nd March-2015 has been conducted in the seven blocks Arsha, Bagmundi, Balarampur, Barabazar, Joypur, Jhalda-I, Jhalda-II, in the District of Purulia. Erection of Flex, Banner, distribution of leaflets & Boklets and sample household survey 50 nos household per G.P in 28 G.P including FGD were conducted.



MOBILE MEDICAL UNIT

Establishment of Mobile Medical Units is one of the innovative schemes initiated by H&FW Dept. Govt. of West Bengal & NRHM to provide health coverage to people living in the unserved and underserved deep interior and remote areas in the state including Purulia District of Paschimanchal.

With the Objectives as follows:

1. To provide Primary, Preventive, Curative, Promotive and Referral Health Services at the door step to the people in the un-served/underserved areas of the state.

2. To engage in providing essential quality Primary Health Care services to the people with diagnostic facilities.

3. To co-ordinate with the District Public Health Systems to achieve improvement in the Millennium Development Goals such as IMR, MMR, Life expectancy etc.

PDAMSMS has been entrusted with the project to operate Medical Camps in 7 nos. GP of Jhalda-I Block of Purulia district from December 2011 with diagnostic and X-Ray facilities

AMBULANCE SERVICE :

Ambulance Service commissioned through Public – Private Partnership under Indo – German Basic Health Project and Health & Family Welfare Govt. of West Bengal, has been working efficiently on almost cost to cost basis since 2004 at Jhalda-I block with a view to provide high quality, easily accessible and timely health care emergency transportation/ referral services for the rural populace in their need. Another Ambulance provided by District Administration to cater to the rural populace in their need. The Ambulances sited in Jhalda BPHC for 24 hours under the control and monitoring of BMOH for its smooth running. 964 nos. Patients including Accident Emergency, Delivery, Child and other related cases benefitted during last year.:

CRECHE:

With a view to promote services to the children of 2-5 years, Creche Service Program was introduced by a sponsored programme of Central Social Welfare Board through W.B. Social Welfare Advisory Board to run two (2) nos. of Creche Centers at Kulajanga and Jargo village under Jhalda-I Panchayat Samiti frtom Aprtil,2007 catering to fifty (50) nos. of children of working and ailing mother of low income group who are provided with Balwadi education training, regular health Checkup with medical care & immunization and supplementary nutrition.

To generate relationship with each other and to keep the children both mentally and physically fit, one-day sports & games competition was organized at Pusti High School Ground on the eve of Children's Day. Children of the Creche units with other Primary Schools participated in different events. Prizes were awarded to the successful candidate.

FOOD PROCESSING TRAINING CENTRE (FPTC) :

PDAMSMS is running Food Processing & Training Centre at Jargo, Jhalda-I for adolescents to provide skill development on Entrepreneurship and different processed food items to build their capacity to establish FP Units of their own and to create scope of Income generation. With assistance from Dept. Of Horticulture & Food Processing, Govt. of West Bengal. Training on Jam & Jelly preparation, pickle making, Squash preservation of processed food etc. including entrepreneurship development were provided to 25 candidates during this reporting year.



BRIDDHI

Project BRIDDHI has been designed by CARE India with the support of GlaxoSmithKline Consumer Healthcare Ltd. to improve the nutritional status of severely malnourished children the BRIDDHI project has been designed by CARE India with the support of GlaxoSmithKline Consumer Healthcare Ltd to improve the nutritional status of severely malnourished children in the age group of 3-6 years though growth monitoring, behavior change communication, strengthening health (including treatment) and nutrition (including Nutrition Rehabilitation Centre) service delivery system. The project also aims to improve the nutritional status among severely malnourished children though adoption by civil society members, coordinate access to and or providing appropriate counseling, referral and treatment services.

The project has being implemented and running successfully in Purulia district piloting in two blocks namely Jhalda-II and Purulia-II in partnership with CARE, India. W.B and works directly with the target beneficiaries to address the gaps in nutrition.

OBJECTIVES OF THE PROJECT:

- improve the nutritional status among severely malnourished children of 3 years through growth monitoring, behavior change communication and strengthening of health & nutrition service delivery systems.
- improve the nutritional status among severely malnourished children through adoption by civil society members, coordinate access to and or providing appropriate counseling, referral and treatment services.

And with that view Sensitization Program and Rural Health Service Providers training TB Volunteers training etc Workshop on Tuberculosis were organized during the reporting year where PRI functionaries, school teachers, community leaders and Health workers participated for planning to combat the situation.

HEVS (Health Education among VHSNC and SHG) Members: A Pilot initiative in Purulia in convergence with NRLM and Health

THE CONCEPT:

The HEVS project thrives to create a convergence between the National Rural Livelihood Mission

(NRLM) and the National Rural Health Mission (NRHM) through the strengthening of SHG subcluster and cluster platforms by training them to promote health education in their monthly meetings subsequently establishing an effective flow of information from the community level to the frontline workers to bring about positive changes in the reproductive health of rural women in the district of Purulia. The project does not include the initiation of any parallel systems or the introduction of any new human resource in its implementation strategy. It seeks only to strengthen the existing platforms which are already operational within the villages (PRI, SHGs, and VHSNCs).

The initiative is being undertaken in 2 Blocks in the district of Purulia covering a total of 8 GPs (4 GPs from each block) and 103 subclusters. In partnership with CARE, India, W.B.

OBJECTIVE OF THE PILOT PROJECT:

Provide health education in monthly meeting of SHGs

Engagement & training of cluster & sub cluster representatives for joint planning and review of health initiatives by SHGs

Aligning of SHG sub clusters with sub centre health activities

Reconstitution, regularization and capacitating of the VHSNCs th

Facilitate Panchayat involvement in the entire process through strengthening of 4 Saturday meetings.

Performance of, Folk media campaign, Quiz competition etc. were organized in different. spots of Jhalda-I, Jhalda-II & Jaypur of Purulia district to generate mass awareness on Violence against women and girl children in Purulia.

Celebration of National Consumers Right Day:

29th National Consumers Right Day was observed across India on 24 December 2014. The day provides an opportunity to highlight the importance of the consumer movement and the need to make every consumer more aware of their rights and responsibilities. Purulia Agragami (PDAMSMS) celebrated the day by organizing a workshop distributing complaints forms, information brochures and other consumer rights literature freely to the participants

The PDAMSMS rewarded with a sum of Ten rupees each to the 30 nos. successful participants of the quiz competition related to different issues on Consumer rights .

Special Health Camps:

Special Health checkups camp ware organized at Sirkabad under Arsha Block on dt.15.03.2015 & jointly with district Police Administration to develop police public relation in respect of medical check

up among the down trodden people. Free medical checkups including pathological & radiology service with free distribution of medicine ware provided .About more then 400 peoples of near by villages attended the cams to carter the services.





Observation of Women's Day:

International Women's Day was observed followed by a series of program like Rally, Seminar, Quiz competition etc. on 8th March, 2015 in 6 nos. GP of Purulia-I and Jhalda-II block. The "Inspiring change" was the main theme of the program and each and every place PRI functionaries, SHG Members AWWs Block officials participated in a large number.





Observation of Safe Motherhood Day

Purulia is among the poorest and one of the backward districts in West Bengal. Female literacy in the district is 20.4 percent as against the state average of 47.3 percent. A staggering 74 percent of women who marry are below 18 years of age. Aptly, this was the first district in the country to pilot the Maternal and Perinatal Death Inquiry & Response, MAPEDIR.

No woman should ever have to face the tragic prospect that she may not survive the unexpected period of pregnancy and childbirth. "Purulia District Agragami Mahila-O-Sisu Mangal Samiti, partner of WRAWB is leading an effort to reduce maternal mortality through its 'National Safe Motherhood Day 2014' campaign, on 11th April 2014. In association with Health Department, PRI, ICDS and SHGs. At Jhalda-II, Purulia-I & Purulia-II blocks of Purulia district.



General Activities:

Like in the past years, Independence Day, Republic Day, were observed in a befitting manner. Cultural programs including recitation etc. were held on the occasion of Rabindra Joyanti. Seminar cum Workshop was organized at Samiti Meeting Hall and a colorful Rally with the local youths was also organized on 5 Feb'2014 to celebrate Swami Vivekananda's birthday.

Organisation's Development Plan for next 5 years :

- Set up 'ASTARAG" a permanent Home for the aged.
- Set up a rural BPO in Jhalda collaboration with a professional agency to promote employment to rural youth.
- Develop "Gurrabera" into a model village Provide Community Water Centre for potable drinking water, dry individual toilets, preventive health care, solar lighting, etc.
- Aim to support 50 underprivileged girl children under the "Support the Girl Child" programme.
- Setup a Skill Development center in JARGO
